## General Data Protection Regulation Policy Statement

- Only process personal data where this is strictly necessary for legal and regulatory purposes, contractual purposes, or to provide a product or service to our clients
- Only process the minimum personal data necessary for these purposes
- Provide clear information to individuals about how their personal data will be used and by whom
- Only retain personal data for the length of time necessary to carry out the defined purpose
- Maintain a documented inventory of the categories of personal information processed by us
- Ensure that personal data is adequate, relevant, accurate and, where necessary, up to date
- Respect individual's rights with regard to their personal data and ensure that it is processed fairly, lawfully and in a transparent manner
- Ensure that personal data is processed in such a way that ensures its security, including protection against unauthorised or unlawful processing and against accidental loss, destruction or damage
- Not transfer personal data to a country or territory outside the European Economic Area unless an equivalent level of protection to that within the EEA is applied
